




**Figure 1:** The “Walking Dead” are the mass-murdering and morally vacuous CCP – Chinese Communist Party. To which, balanced journalism is their anathema and their benediction is “news” subservient to the line of the party with a seven decades long history drenched in genocide, terror and oppression.

His biological mother was the Jewess Emma Kilian who abandoned Klaus on December 9<sup>th</sup>, 1938 fleeing to New York about one month following *Reichskristallnacht* – National Night of Broken Glass when Jewish businesses and establishments were vandalised all over Germany. The genealogical data for Emma Kilan proving her as the biological mother of Klaus Schwab is available on the Geni genealogy website.<sup>28</sup>

Klaus Schwab, a child of National Socialism, has with religious like zeal, dedicated his life to the inexorable encroachment of Big Government into every aspect of our lives – the very epitome of your proposed *Communications Legislation Amendment (Combating Misinformation and Disinformation) Bill 2023* which you masquerade under the Trojan Horse of “defending democracy.” The pertinent question being however; “What type of ‘democracy’ are you ‘preserving’?” Is it “democratic” like the Democratic People’s Republic of Korea (DPRK) or the former East Germany of the German Democratic Republic or the Lao People’s Democratic Republic? Certainly not the Constitutional Republic that is the United States of America as American DEMRATS sycophantically bellow; “**we are protecting our democracy!**” nor the Constitutional Monarchy that is our great country of Australia.

Indeed, dare one dub the “democracy” of your *Communications Legislation Amendment (Combating Misinformation and Disinformation) Bill 2023* as one of two wolves and a sheep voting on “what’s for dinner?” Or no less poignant, is the following from a letter by America’s second president and first vice-president,<sup>29</sup> John Quincy Adams, to John Taylor on December 17, 1814:

“It is in vain to Say that Democracy is less vain, less proud, less selfish, less ambitious or less avaricious than Aristocracy or Monarchy. It is not true in Fact and no where appears in history. Those Passions are the same in all Men under all forms of Simple Government, and when unchecked, [as would indeed be the case with your *Communications Legislation Amendment (Combating Misinformation and Disinformation) Bill 2023*] produce the same Effects of Fraud Violence and Cruelty. When clear Prospects are opened before Vanity, Pride, Avarice or Ambition, for their easy gratification, it is hard for the most considerate Phylosophers and the most conscientious Moralists to resist the temptation.”<sup>30</sup>

Thus embodied in Klaus Schwab’s philosophy of Stakeholder Capitalism as espoused in his “altruistically” titled book *Stakeholder Capitalism: A Global Economy that Works for Progress, People and Planet*,<sup>31</sup> where he writes a dedication to his parents Eugen Wilhelm Schwab and Erika Epprecht [to reiterate, in reality Erika is his step-mother, not his biological mother] who both taught him first-hand the value of education, collaboration, and the stakeholder principle.

However, I think it is safe to say that the brave Dutch farmers, who since time immemorial, are some of the most efficient farmers on the planet, do NOT share his and what seems to me, your likewise enthusiasm for his Stakeholder Capitalism<sup>32</sup> – the epitome of which is embodied by their pro-WEF Prime Minister Mark Rutte’s *Global Co-ordinating Secretariat of **World Economic Forum** Food Innovation Hubs*.<sup>33</sup> All in the name of your dual climate change and “renewable”/unreliable energy scams masquerading under the Trojan Horse of “saving the planet”, to undermine our fundamental freedoms and liberties, as discussed in depth in my meticulously researched essay in progress; *THE CLIMATE CHANGE AGENDA – A CRITICAL ANALYSIS*.<sup>34</sup> Curiously in that essay, I make extensive use of the WayBack Machine.<sup>35</sup> Can you think of any reasons as to why this would be the case? Do I spread “disinformation” in doing so?

For example, in 2006, former US Vice-President Al Gore, a member of the World Economic Forum’s board of trustees,<sup>36</sup> released his climate apocalyptic documentary *An Inconvenient Truth*. That year, The film’s distributor, Paramount, warned in its 2006 synopsis of the film:

“Humanity is sitting on a ticking time bomb. If the vast majority of the world’s scientists are right, we have just ten year’s to avert a major catastrophe that could send our entire planet into a tail-spin of epic destruction involving extreme weather, floods, droughts, epidemics and killer heat waves beyond anything we have ever experienced.”<sup>37</sup>

However, by November 2012, Paramount removed this apocalyptic but embarrassingly erroneous synopsis!<sup>38</sup> No problem! The good old WayBack Machine furnishes a November 27<sup>th</sup>, 2010 archived copy at [https://web.archive.org/web/20101127132653/http://www.paramountpictures.co.uk/films/an\\_inconvenient\\_truth/index.asp](https://web.archive.org/web/20101127132653/http://www.paramountpictures.co.uk/films/an_inconvenient_truth/index.asp)! And does the highlighting of this fact in my Climate essay,<sup>39</sup> make me guilty of spreading disinformation? Or perhaps, it is what you need to deem; **mal**-information – information that is true but with “malicious intent” counter to your narrative of Marxist effluent? Such was the notion of a department being floated around in the U.S. a year ago to fight **mis-dis-mal** information.<sup>40</sup> Moreover, perhaps you need to add the prefix of “**mal**” somewhere in the name for your *Communications Legislation Amendment (Combating Misinformation and Disinformation) Bill 2023*. Dare I suggest *Communications Legislation Amendment (Combating **Mis-Dis-Mal** information) Bill 2023*? I would LOVE to hear your thoughts!

And again in the spirit of “**mal**-information”, in 2007, a UK High Court judge ruled that Al Gore’s *An Inconvenient Truth* contained nine key scientific errors. While not banning its screening in British schools, judge Michael Burton ruled that it could only be shown with guidance notes to prevent political indoctrination.<sup>41</sup> In this ruling, Judge Burton in point 4 stated the following in regard to the 1990s Russian Vostok Antarctic Station ice-cores:

“Mr Gore claims that two graphs, one plotting a rise in CO<sub>2</sub> and the other the rise in temperature over a period of 650,000 years, showed ‘an exact fit’. The judge said that, although there was a general scientific agreement that there was a connection, ‘the two graphs do not establish what Mr Gore asserts’.”<sup>42</sup>

“Do not establish what Mr Gore asserts” – namely, that CO<sub>2</sub> does NOT drive temperature, but rather the reverse. Yes I repeat; the 1990s Vostok ice-core data clearly indicates that CO<sub>2</sub> does NOT drive temperature, but rather the reverse!<sup>43</sup> Moreover, given Al Gore aired his *An Inconvenient Truth* in 2006, one would assume he must have known about this crucial piece of evidence. To which I again pose to you the question: Do I again spread “**mal**-information”, this time in pointing out this critical error in Al Gore’s *An Inconvenient Truth*? – itself a “gospel” of the Climate Apocalypse narrative? And is this still “**mal**-information” in spite of the fact that the raw data confirming temperature leading CO<sub>2</sub> I also sourced from raw data files from the website of the Carbon Dioxide Information

Analysis Center – CDIAC – located at the U.S. Department of Energy’s (DOE) Oak Ridge National Laboratory (ORNL) – which is the primary climate change data and information analysis center for DOE. CDIAC is supported by DOE’s Climate and Environmental Sciences Division within the Office of Biological and Environmental Research (BER).<sup>44</sup> And given such evidence, is it **mal**-information to dub Al Gore’s Climate apocalyptic video “A Convenient Lie”? Commitment to the truth demands no less!

Moreover, as Patrick Moore elucidates in affirming temperature driving CO<sub>2</sub> rather the Climate apocalypse narrative of CO<sub>2</sub> driving temperature;

“However, changes in orbit that alter the distance from the Sun along with changes of tilt could quite conceivably cause changes to the Earth’s temperature regime. [Rather than former NZ PM Jacinda Adern’s farting and burping cows!<sup>45</sup>] And a change in temperature in the atmosphere also means a change in temperature of the world’s oceans causing them to absorb more CO<sub>2</sub> when they cool and to emit more CO<sub>2</sub> when they warm. Moreover, given that the oceans contain almost 50 times as much CO<sub>2</sub> as the atmosphere, just a one percent change in oceanic CO<sub>2</sub> results in a 50 percent change in atmospheric CO<sub>2</sub>.”<sup>46</sup>

To which, one can arrive at perhaps the **mal**-inference, that the Dutch Prime Minister Mark Rutte, with his allegiance to the unelected Klaus Schwab’s WEF, rather than to his fellow countryman, upon whom the true legitimacy of his office rests, is ultimately guilty of treason? Certainly, the **mal**-science of my Climate essay suggests that he is needlessly putting the most efficient farmers on the planet, through hell! And moreover, in the middle of a global food shortage! To which, how can we infer that our governments are truly committed to our best interests? And hence, how can we infer that your *Communications Legislation Amendment (Combating **Mis-Dis-Mal** information) Bill 2023* is in our best interest? The science certainly suggests anything but.

To which I wonder, if your science would support the Massachusetts Institute of Technology’s research, as published on the WEF website,<sup>47</sup> of the “Space Bubble shield concept to **counter the effects of climate change by reflecting the sun’s rays**”? A proposal one could see spawning from the evil head of Spectre from James Bond or Dr. Evil from Austin Powers. Hmmm ... the executive chair of the WEF, Klaus Schwab, seems to fulfil that role perfectly .... although minus the Persian cat! (Heaven forbid! Not that I have anything against cats!) And am I guilty of **mal**-information in mocking this concept of **inexorable pretentious stupidity**?

But while Klaus Schwab’s connections to National Socialism and his devotion to the public-private partnerships of **space-bubble-stakeholder-capitalism** as espoused by his parents are undeniable, the presence of a bust of Vladimir Lenin in his private library,<sup>48</sup> suggests an intriguing trichotomy, or as I describe it, a dystopian trinity of Marxism, Fascism and Crony Capitalism – the latter, as already discussed, Klaus Schwab sanitises with his term of stakeholder capitalism.

All three branches collectively of this dystopian trinity embrace dictatorship and the theme of big government, married to big business encroaching upon every aspect of our lives. Indeed, the Italian Fascist dictator Benito Mussolini stated:

“Fascism should more appropriately be called Corporatism because it is a merger of state and corporate power.”<sup>49</sup>

To which recalls for me, the irony of your COVID-19 jab mandates. For example, in accordance with my divine rights bestowed upon me by God, I made the decision not to take what have since proven to be, dangerous, ineffective and expensive (D.I.E.)<sup>50</sup> Nuremberg Code violating jabs,<sup>51</sup> promoted in culpable preference to decades proven safe, effective and cheap (S.E.C.) early

treatments such as ivermectin and hydroxychloroquine.<sup>52</sup> And no, ivermectin is not just a horse drug, but rather a multifaceted drug of Nobel prize-honoured distinction with indicated efficacy against COVID-19.<sup>53</sup> Moreover, the risk COVID-19 posed to normal healthy children was infinitesimal.<sup>54</sup> Yet the dangerous jabbing of our children was mandated!! Prompting the late but amazing American Orthodox Jewish Doctor Vladimir Zelenko,<sup>55</sup> and proponent of early treatment,<sup>56</sup> to pose the Biblical Old Testament question to your pro-jab ilk:

**“Are you into child sacrifice?” [To the Canaanite God of Child Sacrifice Molech.<sup>57</sup>]**

Or does the opinion of world renowned medical doctors and professionals such as Doctors Robert Malone, Peter McCullough, Paul Merrick, Harvey Risch, Pierre Kory, Richard Urso, Christina Parks, Mary Boden, Harpal Mangat, Aaron Kheriaty, David Wiseman, Jayanta Bhattacharya, Martin Kulldorff, Peter Alexander, Geert Vanden Bossche, Dr. Ben Marvel and the late Dr. Vladimir Zelenko count only as **mal**-information in the dystopian trinity of your Orwellian Ministry of Truth?

Moreover, Wisconsin Republican Senator Ron Johnson, at his *COVID A Second Opinion Conference Washington DC Monday 24th January 2022*, hosting all the above mentioned doctors except Dr. Zelenko, stated the following:

“From the CDC [Yes, even the corrupt American CDC admit this!!]:

Ages 0 to 17 years: 20 per million died.

Ages 65 and over: 90,000 per million died.

From John G. Niedus:

Ages 0 to 19 years: 13 per million died.

Ages 70 and over: 40,000 per million died.”<sup>58</sup>

These figures make the vaccinating of children with dangerous and still chronically under-tested jabs, a reckless disregard for children’s safety upon the pillar of Big Pharma profit.

To which the Senator Johnson then alluded to a report he just received that day, of the tragic and senseless story of a Vietnamese female 9th grader from the northern province of Phu Tho, who got her first Pfizer dose on December 3rd 2021.<sup>59</sup> After which she experienced dizziness and difficulty in breathing. She was taken to a medical centre where she later recovered. Nevertheless, in accordance with the global vaccine mass formation psychosis, on Monday January 17, 2022, just one week before this conference, she had her second jab – despite being in the age group where about only 20 per million die of COVID. Twenty minutes later she experienced tightness in her chest, dizziness, difficulty in breathing and seizures. She received emergency medical treatment on the spot, before being transferred to a district medical centre. On arrival she started to vomit blood, fell into a coma and her hear stopped. She died the following morning of Tuesday January 18, 2022.<sup>60</sup>

**All this for a 20 in a million chance of dying from COVID-19 and the profits of Pfizer.** Yet, Big Pharma shills will maintain this is pure coincidence and not evidence of death by pseudo-vaccine! In the wake of Senator Johnson’s talk, Dr. Merrick alluded to the fact that since kids are 1,000 times more likely to die from riding bicycles than from COVID, we should ban kids from riding bicycles!<sup>61</sup> Such is the mass formation psychosis inanity of the jab narrative.

To which, like the late Dr. Zelenko, I ask you:

**“Are you into child sacrifice to the Canaanite God of Child Sacrifice; Molech?”<sup>62</sup>**

Clearly, the COVID-19 jab mandates embraced what the Italian Fascist dictator Benito Mussolini dubbed “a merger of state and corporate power.” Yet, the corrupt and politically and historically ignorant globalist mainstream media and yourselves, dub people such as myself, aware of our divine rights bestowed upon us by God, upon which our Western Civilisation has been based, as Nazis or Fascists! When indeed your own actions, epitomise yourselves as the very Fascists you accuse us of being! Or is such a fact **mal**-information in the eyes of what would become the dystopian Trinity of your Orwellian Ministry of Truth? And moreover, in spite of the aforementioned National Socialist heritage of Klaus Schwab himself?

Most poignant here, is my justification in not referring to the COVID-19 jabs as so-called “vaccines.” This because the Big Pharma jabs, are only “vaccines” by virtue of the American CDC dramatically watering down the definition of “vaccine” still standing on September 1<sup>st</sup> 2021:

“A product that stimulates a person’s immune system to produce immunity to a specific disease, protecting the person from that disease.”<sup>63</sup> [Thank goodness for the good old WayBack Machine!]

... to merely a cop-out narrative crumbling definition the following day of September 2<sup>nd</sup> 2021:

“A preparation that is used to stimulate the body’s immune response against diseases.”<sup>64</sup>

And just nine days later, the irony of a local Detroit American Bolshevik Collective (ABC) network in a September 11, 2021 Facebook post requesting people to share their stories of beloved **unjabbed** that had died. Naturally, they wanted to make a big story of what they hoped would be a huge scoop for their pro-jab narrative. But what happened next was totally unexpected. In the following five days, over 200,000 (!) people posted comments, **but not about unjabbed beloved ones** – rather about **jabbed loved ones** that died shortly after being injected, or were permanently disabled. The 200,000 comments revealed a shocking death-wave among the population, and the heart wrenching suffering these jabs are causing.<sup>65</sup>

Moreover just four months later, in early January 2022, U.S. District Judge Mark Pittman, ruled that the U.S. Food and Drug Administration (FDA) would not have 75 years [**yes I repeat; 75 years!**] to release thousands of pages of documents it relied on to license the Pfizer COVID-19 jabs. Instead, the federal agency was given just over eight months to do so.<sup>66</sup> Of course, as to why in this universe the FDA claimed they required 75 years to release its documentation to license the Pfizer COVID-19 jabs, can only be reasonably seen as nefarious. To which, in stating the glaringly obvious, am I, in the spirit of your *Communications Legislation Amendment (Combating **Mis-Dis-Mal** information) Bill 2023*, guilty of promulgating **mal**-information? And is it also **mal**-information when I reveal to you that the documentation released by the FDA was damning for Pfizer and so by natural logical extension, the FDA?<sup>67</sup> Naomi Wolf, whose grandmother lost nine siblings in the Holocaust,<sup>68</sup> and has had her team read the reams of very reluctantly released reports, indeed, reports as such.

In concluding my discussion on Klaus Schwab and his WEF, I am compelled to mention his unequivocal admiration for the CCP – Chinese Communist Party – the greatest mass-murderers of all time. For example, in November 2022, Klaus Schwab proclaimed on China’s State TV network CGTN;

“China is a model for many nations.”<sup>69</sup>

And given your proposed *Communications Legislation Amendment (Combating Mis-Dis-Mal information) Bill 2023*, would imply it seems, your in kind admiration for the CCP. To which, I am compelled to enlighten you as to the CCP’s capacity for mass-murder, genocide and oppression. And no, you cannot fob this off as racism towards Chinese, when you did for example in covering for the CCP’s indisputable role in spreading COVID-19 to the world.<sup>v</sup> Such ludicrous logic would then imply I am being racist towards Germans in my book for documenting the atrocities of National Socialism. The mass-murdering CCP, as I will elucidate, does not represent all of the Chinese people. Moreover, this is an issue of ideology, not race, as much as you desperately wish it to be one of race.

Beijing’s increasingly horrific pogrom against ethnic Muslim Uyghurs in the north-west province of Xinjiang, as much Central Asia as it is China, casts a huge human rights and religious persecution shadow over China. Surveillance techniques used in Xinjiang have already emerged elsewhere; the government has installed closed-circuit TV cameras in some Catholic and Protestant churches. Uyghurs, since 2009, have been subjected to extreme repression that has seen the banning of many traditional Islamic practices, mass disappearances, thousands jailed, and hundreds sentenced to death in stadium trials. In the eighteen months preceding September 2018, the pogrom culminated in concentration camps that human rights agencies estimate hold up to a million Uyghurs.<sup>70</sup> As Drew Pavlou, the young University of Queensland (UQ) philosophy student, suspended in mid-2020 for daring to lead protests against the CCP on campus, commented: “This is the largest internment of a people based on their ethnicity since the Holocaust.”<sup>71</sup>

Moreover, according to the final report released on March 1<sup>st</sup>, 2020 by the UK based China Tribunal, chaired by UK now King’s Counsel Sir Geoffrey Nice:

**“Hospitals in the PRC have had access to a population of donors whose organs could be extracted according to demand for them.”<sup>72</sup>**

Prime targets for this heinous practice, are members of the Falun Gong spiritual movement.<sup>73</sup> For the Uyghurs, the CCP are implementing programmes of forced sterilisation and abortion to curb China’s Muslim population, while at the same time, encouraging some of the country’s ethnic Han majority to have more children.<sup>74</sup> And in spite of the rank indifference of the Vatican under Pope Francis supine to the Chinese Communist Party, with his grubby secret deal,<sup>75</sup> underground house Catholics<sup>76</sup> still operate outside of the State sanctioned Chinese Patriotic Catholic Association (CPCA).<sup>77</sup> Moreover, the tyranny of the Chinese Communist Party under Mao Zedong’s famine of “The Great Leap Forward” of 1958-61 resulting in conservatively, the death of 30 million people,<sup>78</sup> and Cultural Revolution of 1966 until his death in 1976.<sup>79</sup>

Furthermore, the June 4<sup>th</sup> 1989 Tiananmen Square massacre under Deng Xiaoping, where the radical American Marxist FRSO – Freedom Road Socialist Organisation, responsible for sparking the late May 2020 race riots in Minneapolis in the wake of George Floyd’s death,<sup>80</sup> claim

Tiananmen Square “as the defeat of counter-revolution in China!”<sup>81</sup> And is the three minute video showing leading members and partners of the radical Marxist FRSO, Steff Yorek and Jess Sundin.<sup>82</sup> <sup>vi</sup> joyously proclaiming their role in sparking the Minneapolis riots in the wake of George Floyd’s death, **mal**-information?

Moreover in the American summer of 2020, such radical leftists were bailed out of gaol by Biden-Harris staff.<sup>83</sup> In March 2021, FRSO launched its Spring Fund raising drive of \$100,000-plus required for its “great leap forward” with the following violent pitch:

“Over the past year, Freedom Road Socialist Organization has undergone a period of dramatic growth, and we have emerged as one of the largest revolutionary organizations in the United States...

... To continue this pace of development we need your help. We are going to establish a national office and we are going to have some full-time staff who are devoted to building FRSO. We will increase our capacity to build a revolutionary movement that is capable of engaging the class enemy and waging a serious fight for working class political power: socialism.

To do this takes money and everyone can play a role in this. Urge your comrades and friends to give all that they can to the FRSO Spring Fundraising drive. Congress and the president just approved stimulus checks for most of us. Please consider contributing your stimulus check to FRSO...

... Some people say real change is impossible. **Burning police stations and millions of people in the streets this past year suggest otherwise.** We want to abolish capitalism and replace it with socialism. This is not some dream; it can be a reality if we work – and fight – for it.

To do that we need to expand the fighting capacity of FRSO. Your contributions, the bigger the better, will help us do exactly that. Go to donate at <https://frso.org/>.

Great [burning] things are ahead!  
The future is [burning] bright!  
Contribute to the FRSO Spring Fundraising campaign!”<sup>84</sup>

Hence, one could sum up FRSO and the like with one of the final lines of the 1848 Communist Manifesto:

“The Communists disdain to conceal their views and aims. They openly declare that their ends can be attained only by the *forcible overthrow of all existing social conditions.*”<sup>85</sup>

To which, is reporting of such content on the website of FRSO and from the 1848 Communist Manifesto in my book,<sup>86</sup> **mal**-information? So many questions – especially on what you would deem it seems, **mal**-information. Which in turn would imply the creation of a bureaucratic behemoth, light years beyond anything envisioned by George Orwell. One could say, the only thing George Orwell got wrong, was the year 1984 – when indeed, it seems more like somewhere in the decade of the 2020s.

But it is now time to move on to the next of your Geneva-based overlords – Tedros Adhanom Ghebreyesus; Director-General of the United Nations agency – the World Health Organisation – WHO – which many have dubbed the “Wuhan Health Organisation” or “We Hurt Others”<sup>87</sup> just to name a few. As I mentioned at the beginning of this submission, Tedros is a mass-murdering Ethiopian communist – to which such a damning statement needs to be correspondingly backed with damning evidence. Such evidence however, is abundant for anyone willing to research beyond your Ministry of “Truth” echo chamber.

Until Friday November 6<sup>th</sup>, 2020, just days following the US Federal “election”, I resolved to no longer listen to corrupt global mainstream media, beholden to your Ministry of “Truth” echo chamber. Since I commenced my job as an electric meter-reader in January 2006, I always listened to ABC – Australian Bolshevik Collective Radio 612 Brisbane when driving to and from work. Moreover, since I was a kid, I had regarded them as an impeccable source of news. However, their disgraceful coverage of the highly questionable 2020 American election, was for me, the final straw. But as well, from the outbreak of the CCP-Fauci-Daszak-GOF virus (Chinese Communist Party-Fauci-Daszak-Gain Of Function virus – more on that in the next two paragraphs) in Wuhan in late 2019, until Friday November 6<sup>th</sup>, 2020, not once, yes I repeat, not once did I hear ABC – Australian Bolshevik Collective Radio 612 Brisbane, ever criticise the Wuhan Health Organisation or their mass-murdering sociopathic CCP overlords. Nor had I heard anything as such reported on any other corrupt global mainstream media outlet.

The term CCP-Fauci-Daszak-GOF (Chinese Communist Party-Fauci-Daszak-Gain Of Function) virus I arrived at due to the following. Anthony Fauci – since December 2022, the former Director of the American National Institute for Health’s (NIH) National Institute of Allergy and Infectious Diseases (NIAID) and America’s highest paid bureaucrat,<sup>88</sup> in a secret teleconference on February 1<sup>st</sup>, 2020, transcripts now show that fellow participants such as Kristian Andersen, Ed Holmes and Bob Gary stated the lab leak theory was the most likely explanation for the leak!<sup>89</sup> However, the obsequious little weasel Fauci was having none of it, and by early March 2020, the aforementioned three scientists published a paper in Nature magazine asserting that:

“We do not believe that any type of laboratory-based scenario is plausible.”<sup>90</sup>

Fauci would later cite this questionable study he almost certainly influenced, for his narrative in Congress.<sup>91</sup> Social media such as Facebook and Twitter, suppressed all discussion of the lab leak theory, but lo and behold, in May 2021, Facebook was compelled to perform a humiliating back flip on what is far away,<sup>92</sup> the most likely theory for the initiation of what became the global spread of the scourge one could dub the Chinese Communist Party (CCP) Virus.

Fauci’s motivation for promoting what now looks like the baseless natural origins theory, makes sense when one considers his NIH funding of the Wuhan Lab’s dangerous Gain Of Function (GOF) research by the NIH via Peter Daszak’s Eco-Health Alliance.<sup>93</sup> Yet still today, the corrupt global MSM treat his word as God, even though in June 2021, he finally admitted the possibility of the lab leak.<sup>94</sup>

Moreover, in another typical example of our corrupt global MSM, on the Sunday night following Joe Biden’s “**inf**raudation”<sup>vii</sup> on Wednesday January 20<sup>th</sup>, 2021, I was watching a documentary on marine archaeology in the Black Sea on SBS. To my great dismay and annoyance, I wrongly assumed that I could watch a non-political historical documentary, minus any propaganda or political indoctrination to further the agenda of corrupt global media. Twice during advert breaks,

there were short so-called “news” clips. They centred around asserting as fact, the prediction that the blithering, vapid, feckless and senile imbecile Joe Biden was going to heal and unite America and his presidency was the “dawn of a new era.”

To begin with, how can the nation heal when the infection of the festering wound, namely rampant election irregularities is ignored? And what wound has Trump inflicted in any case? Perhaps the exposure of the sewer that is the Deep State of Washington DC? Secondly, when Trump was elected in November 2016, the Democrats, at the behest of the bitter loser, Hilary Clinton, commenced a relentless four year witch hunt of Trump’s supposed collusion with Russia in the election.

Nevertheless, in spite of the limitless resources of the FBI – Federal Bolshevik Institute or Federal Bureau of Imbeciles, they found nothing!<sup>95</sup> Yet, the story of the laptop of Joe Biden’s crackhead son Hunter, that broke in October 2020, just weeks before the election, was quashed by our corrupt global mainstream media. To which, it is great that a FREE PDF copy of the crackhead laptop hard drive has been made available online by a young, diligent and patriotic researcher Garrett Ziegler on his website at <https://media.marcopolousa.org/pdf/Report.pdf>.<sup>96</sup> Moreover, recently in a U.S. House Committee hearing, Emma-Jo Morris, former New York Post Editor and current Breitbart politics editor, could not help but laugh while recalling the ludicrous “Russian Disinfo” reasoning behind the censorship of the bombshell [Crackhead] Hunter Laptop Story!<sup>97</sup> To which, am I, Emma-Jo Morris and the young and meticulous researcher Garrett Ziegler, in the Orwellian spirit of your *Communications Legislation Amendment (Combating **Mis-Dis-Mal** information) Bill 2023*, guilty of spreading **mal**-information?

But back to Tedros. In an article dated July 17, 2020 from the *India Narrative*,<sup>98</sup> titled “*WHO chief Tedros, a mass murderer, lectures on leadership qualities*” displaying refreshing independence from corrupt Western media beholden to the CCP and their servile and obsequious vassals that are the WHO, reported:

“There is a saying in Hindi, ‘Chori aur seenazori.’ That is, wrongdoing followed with insolence. This is what we get from World Health Organization Director General Tedros Adhanom Ghebreyesus. Here is a man who played a key role in spreading the coronavirus that has infected millions and killed over half a million people all over the world; and we don’t know when will it stop.”<sup>99</sup>

AND:

“And yet he has the temerity to lecture the world about leadership qualities. “My friends, make no mistake: The greatest threat we face now is not the virus itself,” he said in a speech in Geneva last week. “Rather, it’s the lack of leadership and solidarity at the global and national levels.” The man who should be charged with crimes against humanity continues to hold the highest office responsible for health across the globe. Tedros persists in speechifying; this is intolerable. Something is grievously wrong with the global multilateral agencies.”

“... There is no accountability. Worse, he continues to be the hero of the public health mafia that has done so much harm to mankind in the last few months. Furthermore, the mainstream media continues to see a hero in Tedros because Trump slams him.”

“... But Tedros colluded with Chinese President Xi Jinping to spread Covid-19 in other countries. In the last week of December 2019, top Chinese Communist Party bosses knew about the spread and lethality of the novel coronavirus, but they didn’t inform other countries about it. Had they announced the high transmissibility of the coronavirus three

weeks before when they did, on January 20, Covid-19 casualties would have been 95 per cent less.”<sup>100</sup>

Moreover, in April 2020, Taiwan released the contents of a December 31<sup>st</sup>, 2019 email inquiring about the person-to-person spread of COVID-19,<sup>101</sup> which it says was ignored by the WHO and further denied to provide adequate information about how to fight the virus.<sup>102</sup>

And again from the *India Narrative* dated July 17, 2020,<sup>103</sup>

“It is not clear why did Xi and the CCP want to infect the world but it’s quite evident that they did want to do that—and did that. Nothing else explains their reluctance to inform the world about the dangerous virus. Tedros’ WHO proved to be a willing accomplice.

It lulled the world into believing that the problem was not big. It didn’t recommend travel ban from and to China: Tedros couldn’t anger his masters in Beijing.

Nor did it warn other governments about the gravity of the crisis. In fact, the WHO infamously tweeted on January 14, “Preliminary investigations conducted by the Chinese authorities have found no clear evidence of human-to-human transmission of the novel #coronavirus (2019-nCoV) identified in #Wuhan, #China.”<sup>104</sup> Clearly, Tedros has blood of hundreds of thousands of people on his hand. It is a shame that he is still allowed to head the global health body. The man who should be rotting in some prison cell is pontificating about ‘leadership and solidarity at the global and national levels.’”<sup>105</sup>

Moreover, the free and democratic nation of Taiwan, banned from the United Nations and WHO at the behest<sup>106</sup> of the mass-murdering and genocidal CCP – Chinese Communist Party,<sup>107</sup> in 2020, much to their great credit, did not follow the recommendations of a heavily CCP compromised WHO in late 2019,<sup>108</sup> but rather implemented their own non-lockdown measures to fight COVID,<sup>109</sup> suffering only seven deaths<sup>110</sup> by the end 2020 before the global roll-out of the COVID jabs, in a country just half the size of mainland Tasmania<sup>111</sup> but with a population of 23.8 million<sup>112</sup> – just below that of 25.7 million for our great country.

In short, graphically illustrating how a free, independent and truly democratic country retaining their own medical sovereignty, can thrive without being part of international agencies with nefarious and evil agendas. Put another way, the key to Taiwan’s success was not trusting corrupt officials in Beijing and their obsequious unofficial mouthpiece; the WHO – Wuhan Health Organisation, guilty of disregarding Taiwan’s email on New Year’s Eve 2019, warning of human to human transmission in Mainland China.<sup>113</sup>

All of which points to the present day insanity of the WHO PLandemic Treaty<sup>114</sup> and numerous amendments to the International Health Regulations to essentially promote the mass murdering Ethiopian communist Tedros Adhanom Ghebreyesus; from being the present Director-General of the WHO – Wuhan Health Organisation, to the **Global Medical Dictator General**. (More on that later.)

Here it is most poignant to briefly discuss the pre-Wuhan Health Organisation history of Tedros. In mid-2017, Tedros took office as Director-General of the WHO.<sup>115</sup> People call him “Doctor” but Tedros Adhanom Ghebreyesus is not one – at least not in the classical sense of the term – since he is an academic doctor, having earned a Phd in philosophy, not a degree in medicine.<sup>116</sup> This distinction is not negligible, considering the organisation of which he has been director-general for two years [as at the time of May 20<sup>th</sup>, 2020, the date of the sourced article], and it can provoke mistrust and

disrespect.<sup>117</sup> The World Bank website, while attempting to play-up the qualifications of Tedros, still falls short of calling him a formal medical doctor:

“Born in the city of Asmara, [on March 3<sup>rd</sup>, 1965]<sup>118</sup> in Eritrea, Dr Tedros holds a Doctorate of Philosophy (PhD) in Community Health from the University of Nottingham and a Master of Science (MSc) in Immunology of Infectious Diseases from the University of London.”<sup>119</sup>

While Tedros was born in Eritrea, he was raised in the Tigray region of Ethiopia, the country’s northernmost area. The region was heavily affected by civil war during Tedros’s youth, and diseases such as malaria and measles were prevalent.<sup>120</sup> Hence, he hails himself as a Tigray descendant and is a key member of the Marxist<sup>121</sup> Tigray People’s Liberation Front – TPLF. Tedros Ghebreyesus has been the member of TPLF/EPRDF’s top leaders and has personally participated in decisions that claimed the lives of many innocent Ethiopians including the post 2005 election massacre of hundreds of peaceful demonstrators for which no one has been accountable to date.<sup>122</sup> Moreover, on the website of the TPLF, Tedros himself is listed as an Executive Committee member of the Marxist TPLF,<sup>123</sup> which in turn is listed as a terrorist organisation on the University of Maryland Global Terrorism Database (GTD),<sup>124</sup> and so by logical natural extension, by the U.S. government. Again, hardly someone I would relish in the role of **Global Medical Dictator General** as embodied in the present day insanity of the WHO Plandemic Treaty<sup>125</sup> and numerous amendments to the International Health Regulations, as will be discussed soon.

In the paper titled *International Organizations Leadership Recruitment Policies: the Failed Experiment of Dr. Tedros A. Ghebreyesus Candidacy for WHO Director General Position* by the *Amhara Professionals Union Research Department April 2017* – published just the month before Tedros would be announced as the new Director-General of the WHO, it was documented:

“One of the basic principles of WHO or any other organisation is transparency. Tedros failed to be transparent by forcing the Ethiopian Ministry of Health not to report and cover up a Cholera epidemic throughout most of his tenure by simply renaming a deadly epidemic as Acute Watery Diarrhoea (AWD) despite the isolation of *Vibrio cholerae* as a causative agent. He refused to declare a State of Emergency over the said Cholera epidemic, giving priority to his political agenda and his party’s government image regardless of the effect of this deadly disease on helpless women and children. Due to the lack of a State of Emergency, basic sanitation was not implemented and the capacity to monitor public health surveillance not increased. Many non-governmental organisations (NGOs), both International and Domestic, have reported to have their work stifled by the government if the work either doesn’t align with the political agenda of the government or make the government look good. His worry was impact of a public admission of a Cholera epidemic on tourism and the subsequent political image of his party.”<sup>126</sup>

One could say that a paper written by the rival Ethiopian ethnic group the Amhara is biased against Tedros, who identifies with the Tigray and the Marxist TPLF. However, in September 2017, eighteen American doctors, in an *Open Letter to Dr. Tedros Adhanom Ghebreyesus, Director General of the UN’s World Health Organization, from American physicians United Nations Office at Geneva | Palais des Nations, 1211 | Genève, Switzerland*, blasted the WHO and Tedros himself in regard to the Sudan cholera outbreak that had been raging since August 2016, and well into his term as WHO Director-General, which he assumed in mid-2017.<sup>127</sup>

“Our goal is to build a better, healthier future for people all over the world. Working through offices in more than 150 countries, WHO staff work side by side with governments and other partners to ensure the highest attainable level of health for all people.”

And yet this impressive mandate is daily made a mockery of by WHO's refusal to refer to the cholera epidemic raging in Sudan by name. Neither your organization nor the UN's Office for the Coordination of Humanitarian Affairs will refer explicitly to the fact that what you continue to call "Acute Watery Diarrhea" is in fact cholera, *Vibrio cholera*—a fact established by laboratory tests in Sudan.

What is most troubling in the present crisis is WHO's failure to confirm or disconfirm the findings of Sudanese labs tests in Geneva, using stool samples appropriately transferred from Sudan. As you well know, this is entirely practicable; cholera is easily diagnosed unequivocally in stool samples by bacterial culture. Laboratories across the world can readily do this using a samples shipped to them. If this requires special conditions for shipping (e.g.,specimen has to be collected and stored in a special fluid called transport media to keep the bacteria alive), the effort seems nonetheless unsurpassably urgent, given the spread of what all evidence indicates is cholera, now rampant in most of Sudan."<sup>128</sup>

And from *The New York Times*, dated May 13<sup>th</sup>, 2017 when Tedros was a leading candidate to become the new Director-General of the WHO:

"In an interview, Dr. Tedros, who was Ethiopia's health minister from 2005 to 2012 and remains highly [hmmmmmm????] regarded for his accomplishments then, denied covering up cholera.

Outbreaks occurring in 2006, 2009 and 2011, he said, were only "acute watery diarrhea" in remote areas where laboratory testing "is difficult." That is what the Ethiopian government said then and is saying now about an outbreak that began in January. [2017]

W.H.O. officials have complained privately that Ethiopian officials are not telling the truth about these outbreaks. Testing for *Vibrio cholerae* bacteria, which cause cholera, is simple and takes less than two days.

**During earlier outbreaks, various news organizations, including The Guardian and The Washington Post, reported that unnamed Ethiopian officials were pressuring aid agencies to avoid using the word "cholera" and not to report the number of people affected.**

**But cholera bacteria were found in stool samples tested by outside experts.** As soon as severe diarrhoea began appearing in neighboring countries, the cause was identified as cholera.

United Nations officials said more aid could have been delivered to Ethiopia had the truth been told.

**Somalia, which borders Ethiopia, is currently battling a large cholera outbreak, and a new vaccine is being deployed there.** Aid officials believe cholera is also circulating in the neighboring regions of Ethiopia, but without confirmation, they cannot release the vaccine. **Ethiopia's health ministry is still calling it "acute watery diarrhea,"** and told VOA News last month that it would not change that report without laboratory confirmation, which it said it did not have."<sup>129</sup>

So Ethiopia, still then under the rule of the Marxist TPLF, of which Tedros is an Executive Committee member,<sup>130</sup> claims that while Somalia is suffering a cholera outbreak, the bordering regions of Ethiopia are only experiencing acute watery diarrhoea! This sounds as credible as the

COVID jabs not being responsible in any way for the global excess deaths in spite of these excess deaths coinciding with the global rollout of the COVID jabs!<sup>131</sup> (More on jab-related global excess deaths later.) But as Steve Bannon drolly puts it:

“I don’t believe in conspiracy theories, but there are no coincidences!”

But of course for your ilk, to prop up your litany of crumbling narratives, the likewise litany of pure coincidences devoid of rigorous, thorough and fair investigation, is imperative.

And the Tedros litany of medical malfeasance in Ethiopia is no better exemplified than with its embodiment within the TPLF agenda that has historically labelled the Amharas as the historical enemy of the Tigray people. As highlighted in the *Amhara Professionals Union Research Department April 2017* paper,<sup>132</sup> this is expressed in the TPLF manifesto published in 1975. When Tedros was Minister of the Ethiopian Federal Ministry of Health (FMOH) from 2005 to 2012,<sup>viii</sup> he used his Ministry to play a role in accomplishing the objectives of TPLF. The Amhara population lost more than 2.5 million people between the 1997 and 2007 census compared to the projections. Every major ethnic group showed increase in average of 2.6% whereas the Amharas showed only a 1.9% per annum growth.<sup>133</sup>

Though population growth is politicized in Ethiopia, loss of millions of Amharas is equivalent of genocide and needs further investigation. Given this depopulation of Amharas, no one would expect a contraceptive is the number one priority in “Amhara region” compared to other “Regions”. In addition both Infant Mortality Rate – IMR and Under five Mortality Rate – U5MR was the highest in “Amhara region”. Tedros has served to accomplish the agenda of the TPLF to depopulate Amharas. The “Amhara region” stood at the top only in family planning especially in use of injectable “contraceptives” effectively making many Amhara women barren.<sup>134</sup>

One again could say that this narrative is a biased one coming from the mortal enemy of the Tigray people; the Amhara. However, in *The 1976 TPLF Manifesto and Political instability in Amhara Region, Ethiopia* paper written by the Indian scholars Bamlak Yideg and Peteti Premanandam of the Andhra University in January 2019, stated:<sup>135</sup>

“Gebrmedhin Araya, the former treasure and top leader of TPLF and who left the TPLF (exiled), explained TPLF leaders taught and preached their members as follows:

‘The Amhara are the enemy of the Tigray people. Not only is that, Amhara are the doubled enemy of the people of Tigray. Therefore, we have to hit Amhara. We have to annihilate Amhara. If the Amhara are not destroyed, if the Amhara are not beaten up and uprooted from the earth, the people of Tigray cannot live in freedom and for the government we intend to create, the Amhara are going to be the obstacle.’”<sup>136</sup>

And

“The manifesto that was developed by TPLF had clearly showed the TPLF hate towards Amhara. Unfortunately, the Amhara people did know the manifesto before and during TPLF war [1975-91] against the Military government, the Derg. Through time onwards, academicians, researchers and politicians tried to explore the programs included under the Manifesto and they found it that the Amharas have been singled out as the major target of TPLF’s political struggle for the empowerment of Tigrayans.”<sup>137</sup>

The Derg, a Soviet-backed military junta, took power in 1974 after deposing Emperor Haile Selassie and the Solomonic dynasty, and ruled the country for nearly 17 years amidst the Ethiopian Civil War.<sup>138</sup> On February 18<sup>th</sup>, 1975,<sup>139</sup> the Tigray People's Liberation Front – TPLF – was founded. This was when the TPLF's armed struggle against the Ethiopian government of the time, the military dictatorship of the Dergue (military committee – The Provisional Military Government of Socialist Ethiopia<sup>140</sup>) started in an uninhabited remote region of Tigrai. A handful of Tigraians with four outdated rifles launched the armed struggle from Dedebit in the remote hills of Western Tigrai. In a subsequent protracted struggle that lasted for sixteen years, they mobilized Tigraians behind the front and created a large disciplined army that defeated not only rival fronts but also the military government itself. They finally seized power in Addis Ababa in May 1991 by toppling the military regime, one of the strongest in Sub-Saharan Africa.<sup>141</sup>

The Derg military junta that ruled the country as the PDRE – People's "Democratic" Republic of Ethiopia<sup>142</sup> from 1974 until 1991, was headed by Lieutenant-Colonel Mengistu Haile-Mariam. It was established by a junta of socialist military officers and it was led by army, air force, navy, Imperial Guard, Territorial Army, and police chiefs at its onset. The Derg abolished the monarchy and created a Marxist-Leninist one-party state with itself as the sole legal party.<sup>143</sup>

In 1977, Mengistu Haile Mariam became the Derg's Chairman, initiating a period of "Red Terror" to suppress popular discontent amid the Ethiopian Civil War. Tens of thousands were arrested, imprisoned, and executed without trial, and the humanitarian situation was further exacerbated by a famine from 1983 to 1985 which killed over 1 million people.<sup>144</sup> The famine, the Red Terror, and the Derg's mismanagement of the country led to the ethnic separatist movements gaining strength, and, in 1987, Mengistu abolished the Derg and replaced it with the People's Democratic Republic of Ethiopia in a bid to confer legitimacy upon Ethiopia's communist rulers as a civilian government.<sup>145</sup>

However, the aftermath of the 1983-1985 famine,<sup>146</sup> reliance on foreign aid, and the decline of world communism led to the PDRE becoming increasingly desperate, especially after the USSR cut off aid in 1990.<sup>147</sup> In May 1991, Mengistu fled into exile to Robert Mugabe's Zimbabwe,<sup>148</sup> and the Ethiopian Civil War was brought to an end when Ethiopian People's Revolutionary Democratic Forces – EPRDF forces entered Addis Ababa on 28<sup>th</sup>, May 1991 and founded a transitional government. This transitional government would soon come to be dominated by the TPLF.

Other groups in the victorious EPRDF were the Ethiopian People's Democratic Movement (EPDM) – that later changed its name to the **Amhara** National Democratic Movement (ANDM) – and the Oromo People's Democratic Organization (OPDO).<sup>149</sup> Aregawi Berhe, the author of the paper available on Marxists.org – *A Political History of the Tigray People's Liberation Front (1975-1991): Revolt, Ideology and Mobilisation in Ethiopia*, who is the brother of Tsegaye Berhe – himself, like Tedros, an Executive Committee member of the TPLF, wrote the following in his summary of the May 1991 EPRDF coalition victory over the regime of the "Black Stalin" that was Lieutenant-Colonel Mengistu Haile-Mariam:

"Although one could maintain that the military Dergue [Derg] and the revolutionary guerrilla TPLF espoused basically the same ideology, Marxism-Leninism, yet they were at war against each other for more than sixteen years until the former was defeated by the latter. In military terms and just a year before its downfall, the Dergue was much stronger than not only the TPLF but also all the anti-government fronts in Ethiopia combined. Yet, it was all the way weak in what matters most to the Ethiopian people politically, economically and administratively."<sup>150</sup>

American Marxists it is said, say that their brand of Marxism will not be like the Marxism of Stalin with tens of millions dying/murdered in gulags/purges,<sup>ix</sup> Pol Pot's Cambodian Khmer Rouge responsible for the genocide of 2 million people out of Cambodia's then population of 7 million,<sup>151</sup> the China of Mao Zedong with conservatively 20 million dead from the 1958-61 Great Leap Forward<sup>152</sup> and 1966-76 Cultural Revolution with a minimum of 1.5 million murdered<sup>153</sup> – to which survivors of which now living in America, chillingly liken modern-day WOKE Cultural neo-Marxist America to.<sup>154</sup> x And similarly as indeed does the North Korean defector Yeonmi Park.<sup>155</sup> Likewise, as already discussed, the Marxist-Leninist TPLF liberators of 1991 from the Marxist-Leninist Mengistu regime, were to become mass-murderers, as exemplified by Tedros' term as Ethiopian Health Minister from 2005-2012 characterised by the coverups of cholera outbreaks in 2006, 2009 and 2011,<sup>156</sup> and the depopulation of the Amhara.<sup>157</sup> And later, his obsequious servility to his CCP overlords in 2019-2020,<sup>158</sup> in spreading the CCP-Fauci-Daszak-GOF virus<sup>159</sup> to the world.

During Tigray rule from 1991, discontent was brimming among two largest ethnic groups, the Oromo and Amhara, which threatened the delicate compromise of the 1994 constitution. Representatives of the two communities eventually joined forces to outmanoeuvre the TPLF within the ruling coalition to get Abiy Ahmed, who is of mixed Oromo-Amharic parentage, appointed as prime minister in 2018.<sup>160</sup>

ix Both dictatorships (National Socialism and Communism) used terror, but in somewhat contrasting ways. Anyone in Soviet Union, including those from the most elite, could run afoul of the terror, and in that sense it was completely arbitrary. How can one sum up all the suffering or even the fatalities resulting from the continuous Communist terror from 1917 to Stalin's death? Starting with all the deliberate murders in the civil war, the famines, and forced collectivisation, there are those killed in the Great Terror and during the wartime ethnic cleansing, the Red Army soldiers executed by their own on various grounds, and all those who died or were killed in the Gulag.

Aleksandr Solzhenitsyn suggested that Soviet authorities used "internal repression" from the October Revolution up to 1959 to kill an estimated sixty-six million. He admits the figure is tentative and will need adjusting by future research. He had been a "true believer" himself and for a time held on to his faith in Communism even in the Gulag. His book points an accusing finger at anyone today, in his own country or anywhere else, who might suggest there were "productive" aspects to Soviet terror. More recent estimations of the Soviet-on-Soviet killing have been more "modest" and range between ten and twenty million. In any event, Anne Applebaum, the Pulitzer Prize-winning author in 2004 of *Gulag: A History of the Soviet Camps*, is right to insist that the statistics "can never fully describe what happened." They do suggest, however, the massive scope of the repression and the killing.

When Molotov, Stalin's foreign minister was asked about the use of torture to extract confessions, how clearly innocent family members were killed for nothing, and why it never seemed to occur to Stalin "that we could not possibly have so many enemies of the people" inside the Soviet Union itself, Molotov's reply was:

"It is certainly sad and regrettable that so many innocent people died. But I believe the terror of the late 1930s was necessary. Of course, if we had used greater caution, there would have been fewer victims, but Stalin was adamant on making doubly sure: spare no one, but guarantee absolute stability in the country for a long time—through the war and post-war years, which was no doubt achieved. I don't deny that I supported that view. I was simply not able to study every individual case... It was hard to draw a precise line where to stop ... That policy of repression was the only hope for the people, for the Revolution. It was the only way we could remain true to Leninism and its basic principles."

x Back in 2001 in Hobart, I asked a lifetime female socialist and admirer of Mao Zedong; "What about the 20 million people who died in Mao Zedong's 1958-61 Great Leap Forward?" To which she replied with classical Maoist logic; "What's 20 million people for China?" I kid you not!

Abiy moved swiftly. Top TPLF officials were sacked from key security posts, generals were arrested on graft charges, and changes were introduced to counter the Tigrayan dominance of the armed forces. Political prisoners were freed from secret prisons, exiled dissidents were welcomed home, cumbersome state enterprises were privatised, and restrictions on the media were eased.<sup>161</sup>

Abiy's peace deal with Eritrea, which won him the 2019 Nobel peace prize,<sup>162</sup> isolated the TPLF. By the summer of 2020, simmering tensions had risen further. The TPLF refused to hand over wanted fugitives or join a new political party set up by Abiy to replace the old ruling coalition, and it went ahead with local elections in Tigray despite polls being postponed nationwide owing to the coronavirus pandemic.

The spark that ignited the next Ethiopian ethnic charged powder keg came in early November 2020 with an alleged raid by TPLF units on federal military bases in Tigray,<sup>163</sup> in which many national army officers were killed and substantial quantities of hardware was seized. Abiy launched his offensive immediately. Two years later, on November 2, 2022 representatives of the Ethiopian federal government and the TPLF agreed to a cessation of hostilities after peace talks led by the African Union (AU) in South Africa.<sup>164</sup> However, this was not before June 10<sup>th</sup>, 2021, when the UN and international aid groups reported more than 350,000 people in Tigray were facing famine, with millions more at risk.<sup>165</sup>

***At this point, let us take a breathe and stock of the research and evidence I have just presented on Tedros and his Marxist-Leninist TPLF.***

Before I discussed the history of Ethiopia since the overthrow of Emperor Haile Selassie by the Soviet-backed Derg military junta of the Black Stalin that was Lieutenant-Colonel Mengistu Haile-Mariam, and the founding in its wake in 1975 of the Marxist-Leninist but still rival TPLF, I alluded to the present day insanity of the WHO PLandemic Treaty<sup>166</sup> and numerous amendments to the International Health Regulations (IHR) to essentially promote the mass-murdering Ethiopian communist Tedros Adhanom Ghebreyesus; from being the present Director-General of the WHO – Wuhan Health Organisation, to the **Global Medical Dictator General**. Since then, the evidence I have presented clearly illustrates that the label of “mass-murdering Ethiopian communist” for Tedros – an Executive Committee member of the violent Marxist-Leninist TPLF,<sup>167</sup> is well and truly deserved.

To which is thus reinforced; the proposed Orwellian insanity of promoting Tedros from being the present Director-General of the WHO – Wuhan Health Organisation, to the **Global Medical Dictator General**. Hence, my recent submission to my Federal member Jim Chalmers and my Queensland senators, in requesting that our PM Anthony Albanese demands the exit of Australia from Tedros' Wuhan Health Organisation. Especially disturbing is the proposed amendment to *Article 3 Principles – Paragraph 1* of the International Health Regulations (IHR) as follows:

“1. The implementation of these Regulations shall be ~~with full respect for the dignity, human rights and fundamental freedoms of persons~~ based on the principles of equity, inclusivity, coherence and in accordance with their common but differentiated responsibilities of the States Parties, taking into consideration their social and economic development.”<sup>168</sup>

The striking out of “***dignity, human rights and fundamental freedoms of persons***” can only have nefarious intent. **Moreover, you must understand that these proposed amendments cannot be stopped by Parliament if they are adopted by the World Health Assembly in May 2024. These negotiations must be stopped immediately.** To which, does my highlighting of this opaque attempt, resplendent in its viral Orwellian insanity to promote the mass murdering Ethiopian

communist Tedros Adhanom Ghebreyesus, from being the present Director-General of the WHO – Wuhan Health Organisation, to the **Global Medical Dictator General**, again make me guilty of promulgating **mal**-information?

Curiously, Taiwan suffered spikes in COVID deaths in June 2021 and then again and much more severely eleven months later in May 2022.<sup>169</sup> By mid-May 2021, Taiwan had recorded a still remarkably low 15 deaths, but by the 30<sup>th</sup> May 2021, it had recorded 109 deaths. By July 31<sup>st</sup>, it was 787 deaths. By the end of August it more or less plateaued at 835 deaths.

But what is most pertinent here, is that around mid-March of 2021, Taiwan began COVID-19 jabbing of its people,<sup>170</sup> when it only had recorded 10 deaths. Up until that time, now 15 or so months into the COVID pLandemic,<sup>171</sup> Taiwan had exercised its God given medical sovereignty with remarkable results. But now that it had embarked on the WHO recommended global policy of COVID jabbing, it had in just the next three months, suffered an eighty-fold increase in deaths! Yes, I repeat; an eighty-fold increase in deaths! Pro-jabbers would of course say it is just a coincidence and to blame the COVID-jab is their dead horse beaten claim of conspiracy theory. But as Steve Bannon drolly puts it:

“I don’t believe in conspiracy theories, but there are no coincidences!”

To which, does that make Steve Bannon guilty of promulgating **mal**-information? And am I likewise guilty again for spreading **mal**-information for merely pointing out that Taiwan suddenly experienced an exponential growth in COVID deaths, just two to three months after they started rolling out D.I.E. COVID jabs in mid-March 2021?

However, a much worse COVID jab induced or “coincidental” tragedy was to come for Taiwan in the following year of 2022. Firstly, in early December 2021, the Taiwanese capital of Taipei started offering a third dose of COVID-19 vaccines to people in the top three priority groups for vaccination through arranged sessions, as well as to other eligible recipients at 18 hospitals in the city, as stated by Taipei Mayor Ko Wen-je (柯文哲).<sup>172</sup> Moreover, with a batch of Moderna vaccines expiring on Thursday the 9<sup>th</sup> December 2021, the city government offered NT\$100 (about \$5 Australian) gift certificates to those who get their jab, before that date!<sup>173</sup>

However, by April 2022, people considered to be at greater risk of contracting COVID-19 had to show proof of three COVID jab shots in order to work from April 22<sup>nd</sup>, 2022.<sup>174</sup> Such measures no doubt, would have been in complete alignment with recommendations of Tedros’ Wuhan Health Organisation and to which, Taiwan’s COVID deaths started to sky-rocket from early to mid-May 2022. On May 9<sup>th</sup>, 2022, Taiwan’s COVID death toll stood at 931,<sup>175</sup> but by July 14<sup>th</sup>, it grew exponentially to 7,917! Moreover, it would not plateau until it reached 19,005 as recently as March 29<sup>th</sup>, 2023! Moreover, a quick look at graphs shown in Robert F. Kennedy Junior’s meticulously researched book [The Real Anthony Fauci: Bill Gates, Big Pharma, and the Global War on Democracy and Public Health](#)<sup>176</sup> graphically illustrate that Taiwan is far from alone with Vietnam another most poignant case in point among many others.

To which again I ask you, in the spirit of your proposed *Communications Legislation Amendment (Combating **Mis-Dis-Mal** information) Bill 2023*, am I guilty of again spreading **mal**-information? To which I must remind you of Steve Bannon’s droll motto:

“The head of Indianapolis-based insurance company OneAmerica said the death rate is up a stunning 40% from pre-pandemic levels among working-age people.

‘We are seeing, right now, the highest death rates we have seen in the history of this business – not just at OneAmerica,’ the company’s CEO Scott Davison said during an online news conference this week. ‘The data is consistent across every player in that business.’

OneAmerica is a \$100 billion insurance company that has had its headquarters in Indianapolis since 1877. The company has approximately 2,400 employees and sells life insurance, including group life insurance to employers nationwide.

Davison said the increase in deaths represents ‘huge, huge numbers,’ and that’s it’s not elderly people who are dying, but ‘primarily working-age people 18 to 64’ who are the employees of companies that have group life insurance plans through OneAmerica.

‘And what we saw just in third quarter, we’re seeing it continue into fourth quarter, is that death rates are up 40% over what they were pre-pandemic,’ he said.

**‘Just to give you an idea of how bad that is, a three-sigma or a one-in-200-year catastrophe would be 10% increase over pre-pandemic,’ he said. ‘So 40% is just unheard of.’**”<sup>177</sup>

I reiterate, **“Just to give you an idea of how bad that is, a three-sigma or a one-in-200-year catastrophe would be 10% increase over pre-pandemic,” he said. ‘So 40% is just unheard of.’**”

This is from the CEO of a Life Insurance company OneAmerica founded in 1877! To which, the stark reality of life and death, rather than your nefarious narrative, is their financial bottom line. And to which, does the pointing out of such an immutable and logical truth, in the nefarious spirit of your *Communications Legislation Amendment (Combating **Mis-Dis-Mal** information) Bill 2023*, classified as **mal**-information? And rest assured, this article was only ground-zero for myself in regard to global excess deaths. If you wish to be enlightened further, I can furnish you with countless other reports, such as in the EU; “Excess mortality rose sharply to 19% in December 2022”<sup>178</sup> as reported on the official EU Eurostat website. My reporting of which to you again, must be another manifestation of the spirit of **mal**-information as embodied in your *Communications Legislation Amendment (Combating **Mis-Dis-Mal** information) Bill 2023*.

As Dr. Robert Malone wrote two days later on January 3<sup>rd</sup>, 2022:

“AT A MINIMUM, based on my reading, one has to conclude that if this report holds and is confirmed by others in the dry world of life insurance actuaries, we have both a huge human tragedy and a profound public policy failure of the US Government and US HHS system to serve and protect the citizens that pay for this “service”.

IF this holds true, then the genetic vaccines so aggressively promoted have failed, and the clear federal campaign to prevent early treatment with lifesaving drugs has contributed to a massive, avoidable loss of life.

AT WORST, this report implies that the federal workplace vaccine mandates have driven what appear to be a true crime against humanity. Massive loss of life in (presumably) workers that have been forced to accept a toxic vaccine at higher frequency relative to the general population of Indiana.

FURTHERMORE, we have also been living through the most massive, globally coordinated propaganda and censorship campaign in the history of the human race. All major mass media and the social media technology companies have coordinated to stifle and suppress any discussion of the risks of the genetic vaccines AND/OR alternative early treatments.”<sup>179</sup> [Such as the aforementioned decades proven safe, cheap and effective ivermectin and hydroxychloroquine.<sup>180</sup> Or does the informed and qualified opinion of a world renowned doctor pre-COVID, but since vilified by your ilk, not count?]

Certainly from your ilk, I have heard that “correlation does not automatically imply causation.” This is of course, one of your inexorably rare grains of truth. However, causation always has correlation, which always demands fair, unbiased and objective investigation. If you refuse to undertake such investigations, one can only conclude that you are terrified as to where such investigations would lead. To which, the following quote below from a so-called “official study” published in the American National Institute for Health’s National Library of Medicine, titled *Covid 19 vaccines and the misinterpretation of perceived side effects clarity on the safety of vaccines*, nefariously attempting to explain jab deaths in 2022, seems to confirm your fear as to where fair, unbiased and objective investigations would lead:

“Fear mongering and misinformation being peddled by people with no scientific training to terrorise people into staying unvaccinated is not just causing people to remain susceptible to viral outbreaks, but could also be causing more side effects seen in the vaccination process. This brief review will offer data that may demonstrate that misinformation perpetuated by the anti-vaccination movement may be causing more deaths and side effects from any vaccine. **[But as already iterated, they are only “vaccines” by virtue of a radically diluted and nefarious CDC redefinition in early September 2021.**<sup>181</sup>]

A mini review of published literature has been conducted and **found that mental stress clearly causes vasoconstriction and arterial constriction of the blood vessels. Therefore, if subjects are panicked, concerned, stressed or scared of the vaccination, their arteries will constrict and become smaller in and around the time of receiving the vaccine.**<sup>182</sup>

Honestly but honestly ... in the spirit of your *Communications Legislation Amendment (Combating Mis-Dis-Mal information) Bill 2023*, am I supposed to take the above, just because it was published in the American National Institute for Health’s National Library of Medicine, seriously?? **Fair dinkum!! You cannot make this up!! This is Bizarro World!! No doubt, you must be terrified where a fair, honest and objective investigation into excess deaths globally would lead!!**

To which, a video version of incontrovertible evidence of the malevolent agenda of the Big Pharma jabs was furnished in late January this year of 2023 by James O’Keeffe of Project Veritas. It started with a Project Veritas male staff member surreptitiously filming Jordon Trishton Walker, *Director, Worldwide R&D Strategic Operations and mRNA Scientific Planning* at Pfizer in New York City, revealing that Pfizer might consider creating mutated forms of COVID-19 to develop highly profitable vaccines, using a process Walker termed “Directed Evolution.” During this conversation, Walker stated:

“Don’t tell anyone. Promise you won’t tell anyone. The way it [the experiment] would work is that we put the virus in monkeys, and we successively cause them to keep infecting each other, and we collect serial samples from them,” he said.”<sup>183</sup>

Later James O’Keefe himself approached Walker and revealed to Walker the video of the conversation Walker had earlier with one of the staff of Project Veritas. This sent Walker into complete meltdown.<sup>184</sup> Firstly, Walker claimed that he was a liar and was just trying to impress a [gay] date.<sup>185</sup> Then he tried to seize James O’Keefe’s ipad, which resulted in it slipping out of James O’Keefe’s hands and crashing on the floor. Walker then tried to get the café staff to lock the doors before police eventually arrived.<sup>186</sup>

Dr. Robert Malone in the first video from 1 minute 24 seconds, states that:

In spite of Walker’s LinkedIn almost immediately after being deleted, I was able to go to Signal Hire at <https://signalhire.com/candidates/bdc539145ace11e68155feb79ce8b6d8>, open an account with Signal Hire, and see that indeed, Jordon Trishton Walker, at least at the time, was the *Director, Worldwide R&D Strategic Operations and mRNA Scientific Planning* at Pfizer in New York City. To which, I have uploaded a screenshot of Walker’s Signal Hire résumé to my website as well as a PDF exported copy, and an informative screenshot of a Qwant search of mine of Jordon Trishton Walker made on Saturday 28<sup>th</sup>, January 2023.<sup>xi</sup>

Yet, countless corrupt global mainstream media “fact” checkers, claim there was nothing to these videos. As a cheating husband would say to his faithful wife catching him in the act:

“Do you believe me or your lying eyes??”

I have of course, since the outbreak of the CCP-Fauci-Daszak-GOF virus,<sup>189</sup> learned to trust my common sense rather than your nefarious agenda-driven narratives, which are in 2023, as this dystopia passes it seems, the inflection point of the exponential curve,<sup>xii</sup> becoming more and more brazenly obvious! To which, in the spirit of your *Communications Legislation Amendment (Combating **Mis-Dis-Mal** information) Bill 2023*, in revealing the Pfizer litany of scandal, am I guilty of promulgating **mal**-information – even though, the source given for each scandal, was your very own, duplicitous mainstream media? Moreover, the big three of your jab manufacturers; Pfizer, Moderna and

Astrazeneca are all partners of Klaus Schwab's World Economic Forum,<sup>191</sup> which in turn, as will be discussed later, signed a "Strategic Partnership Framework" with the United Nations in New York, on the 13<sup>th</sup> June, 2019,<sup>192</sup> just months before the outbreak of COVID-19 in Wuhan. **Sorry ... well no ... not sorry ... Well, there was the Black Death **Pandemic**, but not **PLandemic** of the 14<sup>th</sup> century, that had yes, an untold effect on the social fabric of Europe.<sup>198</sup> But when Schwab and his cronies talk of **"to reset and reimagine our world through the "opportunity of their COVID PLandemic,"**<sup>199</sup> questions as to their true agenda, must be raised! Such as the obliteration of our fundamental freedoms and rights to serve the agendas of garbage elite unelected sociopaths.

Moreover, Kirsten Salyer, Head of Editorial Strategy and Thought Leadership at the World Economic Forum,<sup>200</sup> in an article dated Tuesday the 15<sup>th</sup> October 2019,<sup>201</sup> reported:

"Geneva, Switzerland, 15 October 2019 – The Johns Hopkins Center for Health Security in partnership with the World Economic Forum and the Bill & Melinda Gates Foundation will host **Event 201: a high-level simulation exercise for pandemic preparedness and response**, in New York, USA, on **Friday 18 October, 08.45 - 12.30 EDT.**"<sup>202</sup>

And on the Johns Hopkins Centre for Health Security web page, the scenario simulated was reported as follows:

“Event 201 simulates an outbreak of a **novel zoonotic coronavirus** transmitted from bats to pigs to people that eventually becomes efficiently transmissible from person to person, leading to a severe pandemic.”<sup>203</sup>

Of course, as already discussed, while the zoonotic origin of the Wuhan corona virus was virulently pushed by your ilk, including Anthony Fauci and his cronies, it has never been backed by a shred of evidence.<sup>204</sup>

The Event 201 scenario, after it originated in South America, it ended as follows:

“The scenario ends at the 18-month point, with 65 million deaths. The pandemic is beginning to slow due to the decreasing number of susceptible people. The pandemic will continue at some rate until there is an effective vaccine or until 80-90 % of the global population has been exposed. From that point on, it is likely to be an endemic childhood disease.”<sup>205</sup>

And as Norbert Häring, the author of this April 26<sup>th</sup>, 2020 article most poignantly put it:

“It is true that if a little less emphasis had been placed on **opinion manipulation** [Sound familiar???], more attention could have been paid to health and economic policy. One of the four meetings was entirely devoted to this. But health and economic policies did get discussed. Gates can hardly have forgotten that.”<sup>208</sup>

Of course, the corrupt global mainstream media outlet; USA Today, invoked the dead-horse-beaten but trusty “coincidence” go-to:

“Although Event 201 was a real event affiliated with high-profile medical professionals, business leaders and government actors, the claim that the event predicted the current pandemic, or is tied to it directly in some way, is unfounded. We rate this claim FALSE because it is not supported by our research. There is no reason to believe that the current pandemic will resemble the Event 201 simulation, **despite coincidences in the modelling and timing of the simulation.**”<sup>209</sup>

And to further reinforce the pLandemic theme of COVID-19, is that in 2017 and 2018, hundreds of millions of COVID-19 Test Kits were distributed worldwide. Which implies of course, foreknowledge of malevolent players for a coming pLandemic that would become known as COVID-19.<sup>210</sup>

On July 5<sup>th</sup>, 2023, a paper titled a *A SYSTEMATIC REVIEW OF AUTOPSY FINDINGS IN DEATHS AFTER COVID-19 VACCINATION*<sup>213</sup> by Nicolas Hulscher, BS, Paul E. Alexander, PhD, Richard Amerling, MD, Heather Gessling, MD, Roger Hodgkinson, MD, William Makis, MD, Harvey A. Risch, MD, PhD, Mark Trozzi, MD, Peter A. McCullough,<sup>xiv</sup> MD, MPH was published on the Lancet Medical Journal’s pre-print server – namely, the server where researchers can place their studies in order for them to get peer-reviewed.<sup>214</sup> According to one of the authors, Dr. Peter McCullough, who according to Research Gate, has hundreds of peer-reviewed papers he has authored or co-authored,<sup>215</sup> and was the lead researcher for this paper, and despite the fact that this study was experiencing “hundreds of reviews per minute,” the Lancet Medical Journal decided to pull it down!<sup>216</sup>

The reason being it seems, was that its findings were as follows:

“The most implicated organ system in COVID-19 vaccine-associated death was the cardiovascular system (53%), followed by the hematological system (17%), the respiratory system (8%), and multiple organ systems (7%). Three or more organ systems were affected in 21 cases. The mean time from vaccination to death was 14.3 days. Most deaths occurred within a week from last vaccine administration. A total of 240 deaths (73.9%) were independently adjudicated as directly due to or significantly contributed to by COVID-19 vaccination.”<sup>217</sup>

... and interpretation as follows:

“The consistency seen among cases in this review with known COVID-19 vaccine adverse events, their mechanisms, and related excess death, coupled with autopsy confirmation and physician-led death adjudication, suggests there is a high likelihood of a causal link between COVID-19 vaccines and death in most cases. Further urgent investigation is required for the purpose of clarifying our findings.”<sup>218</sup>

No wonder now, when I hear anyone say they are an “expert,” I ask;

**“So what is your agenda?”<sup>xv</sup>**

And indeed:

**“What is yours??”**

Of course, such an inexorably stupid and pretentious officially approved narrative as espoused in the *Covid 19 vaccines and the misinterpretation of perceived side effects clarity on the safety of vaccines* paper, as published on the website of the American National Institute for Health’s National Library of Medicine in 2022, would no doubt, please your Chinese Communist Party **BEHOLDEN** sociopathic overlords in Geneva – Klaus Schwab of the World Economic Forum, and Tedros Adhanom Ghebreyesus of the Wuhan Health Organisation or “We Hurt Others”.<sup>219</sup> To whom it seems to me, given the litany of damning evidence and research I have just presented, you are committed to ceding our fundamental freedoms, rights and liberties bestowed upon us by God himself as poignantly documented in the famous anathema to your Orwellian agenda; the 1776 American Declaration of Independence:

“We hold these truths to be self-evident, that all men are created equal, that **they are endowed by their Creator with certain unalienable Rights**, that among these are Life, Liberty and the pursuit of Happiness.--That to secure these rights, Governments are instituted among Men, deriving their just powers from the consent of the governed, --That whenever any Form of Government becomes destructive of these ends, [such as among other things the WHO IHR/PLandemic Treaty<sup>220</sup> and the Catastrophic Climate Change Scam<sup>221</sup>] it is the Right of the People to alter or to abolish it, and to institute new Government, laying its foundation on such principles and organizing its powers in such form, as to them shall seem most likely to effect their Safety and Happiness.”<sup>222</sup>

The American Founding Fathers were geniuses and intellectual giants of all time dedicated to the betterment of humanity which has only known two centuries, four decades and seven years of liberty of the Great American experiment – itself, still barely a blip amidst the entirety of human

history, dominated by tyranny that the Globalist ilk of Klaus Schwab and Tedros – to whom you seem beholden, are virulently dedicated to re-establishing.

Yes, George Washington and some of the Founding Fathers owned slaves. However, this has to be looked at in the context of the time. Slavery was ubiquitous in the world at that time. In Africa, the indigenous tribes themselves practised slavery as they waged perpetual battles between themselves. Moreover, the European trade of African slaves would never have been possible without willing collaboration between indigenous tribes and the European slave traders.<sup>223</sup> Hence, the WOKE Critical Race Theory (CRT) narrative of infinitely virtuous black people versus infinitely wicked and irredeemable white people,<sup>224</sup> one can only view, through the lens of objective history rather than Marxist ideological agenda, as infantile.

In other words, contrary to the Black Lives Matter/CRT/Cultural neo-Marxist<sup>225</sup> WOKE agenda, slavery was not something unique to the US or Western civilisation in general. Indeed, the Muslim slave trade started long before the European slave trade and continued long after.<sup>226</sup> In short, there is nothing specifically Western about slavery; but everything specifically Western about abolitionism.<sup>227</sup> For one thing, the bloody civil war fought from 1861-65 in America with the issue of slavery being front and centre.

The multi-lingual American Founding Fathers, who truly risked everything in defying the greatest world power at the time that was Great Britain, all had a prodigious intellect as their masterpieces of Freedom and Liberty; namely the 1776 Declaration of Independence, 1789 Constitution and their Bill of Rights self-evidently attest to. To which the following is most poignant:

“If the American and our Aussie Founding Fathers, the latter of which Constitution adopted many elements of their American counterpart, were walking through a cow paddock barefoot, the likes of Globalist despots like Klaus Schwab and Tedros, the pretentious cultural neo-Marxist WOKE imbeciles of our modern-day crumbling Western civilisation, and yourselves – the proponents of this hideous Orwellian bill, would be the cow dung between their toes!”

On July 17<sup>th</sup> this year of 2023, Jan Jekielek, Senior Editor with The Epoch Times, host of the show “American Thought Leaders” and producer of the award-winning Holocaust documentary film “Finding Manny”, interviewed Aaron Siri, managing partner at the American law firm Siri & Glimstad, to discuss the landmark First Amendment case *Missouri v. Biden*.<sup>228</sup> A most poignant quote from Aaron was as follows:

“I think this might be one of the most consequential decisions in First Amendment jurisprudence in 200 years. You have a federal judge, in a case brought by two states in America—so, two attorney generals: Missouri and Louisiana—saying that the federal government has violated the First Amendment of the United States Constitution by colluding widely with social media companies to censor speech.”<sup>229</sup>

Hmmmmmm! Do we not have a parallel case here in Australia? In his 155 page ruling on of all days, the 4<sup>th</sup> July, 2023, (Independence Day! – How about that??!!) Terry A. Doughty, United States District Judge for the Western District of Louisiana Monroe Division, documented the following in the introduction of his ruling:

“This case is about the Free Speech Clause in the First Amendment to the United States Constitution. The explosion of social-media platforms has resulted in unique free speech issues—this is especially true in light of the COVID-19 pandemic. If the allegations made by Plaintiffs are true, the present case arguably involves the most massive attack against free

speech in United States' history. [As indeed does your *Communications Legislation Amendment (Combating Mis-Dis-Mal information) Bill 2023 here in Australia!*] In their attempts to suppress alleged disinformation, the Federal Government, [The fraudulently elected O'Biden DC sewer<sup>xvi</sup> junta.<sup>230</sup>] and particularly the Defendants named here, [to which you are the parallel party here.] are alleged to have blatantly ignored the First Amendment's [Our Australian Constitution's] right to free speech."<sup>231</sup>

Then on page 3 of his ruling,<sup>232</sup> Judge Doughty quoted Benjamin Franklin from 1772:

"Whoever would overthrow the liberty of a nation must begin by subduing the free acts of speech."<sup>233</sup>

And from Franklin's fellow founding father Thomas Jefferson, and the first sentence on page 3 of Judge Doughty's ruling:

**"Reason and free enquiry are the only effectual agents against error.** Give a loose to them, they will support the true religion, by bringing every false one to their tribunal, to the test of their investigation. **They are the natural enemies of error, and of error only.**"<sup>234</sup>

Thomas Jefferson brilliantly elucidating the purest distilled embodiment of the antithesis to your horrendous Orwellian "Ministry of Truth" Bill:

**"They are the natural enemies of error, and of error only."**

Hmmm ... like my reference early on to the Ancient Greek Open Market Place of Ideas. I'm sure the American Founding Fathers were most familiar with it too.

And at the conclusion of Judge Doughty's ruling quoting President Harry Truman in 1950:

"Once a government is committed to the principle of silencing the voice of opposition, it has only one place to go, and that is down the path of increasingly repressive measures, **until it becomes a source of terror to all its citizens and creates a country where everyone lives in fear.**"<sup>235</sup>

It seems that 73 years ago, U.S. President Harry Truman to his Congress in August 1950, eerily elucidated the very essence of your *Communications Legislation Amendment (Combating Mis-Dis-Mal information) Bill 2023*. And does my quoting of Judge Doughty's 4<sup>th</sup> of July 2023 ruling, the American Founding Fathers Benjamin Franklin and Thomas Jefferson and finally President Harry Truman, make me guilty of promulgating **mal**-information?

Aaron Siri towards the end of his interview with Jan Jekielek, also made a brilliantly poignant point. Namely, and I paraphrase:

"Fundamental rights are only valuable in hard times. If they do not stick in the hard times, you might as well not have them at all. That is why they are there! In 1791, when Aaron said the fledgling American states ratified their First Amendment for Free Speech, do you think times were easy? No! Disease was rampant. Think about the living conditions at the time. We have become soft. Take an ipad or iphone from someone for a month and they will go into meltdown."<sup>236</sup>

But another disturbing issue that again ultimately ties in with your *Communications Legislation Amendment (Combating Mis-Dis-Mal information) Bill 2023*, is an explosive article I received back in early May, from the mailing list of the Stop World Control website.<sup>237</sup> To put it all too mildly, it was truly disturbing and chilling. Especially given the fact that publicly available UN documents from their various sub-entities and closely linked non-government organisations (NGOs), as sourced by Stop World Control,<sup>238</sup> made this all too clear.

The first document that caught my attention, indeed referenced at Stop World Control,<sup>239</sup> but which I first heard about when I listened to the Faith and Reason show on Life Site News<sup>240</sup> from 2 minutes 10 seconds to 29 minutes in, but especially from 9 minutes 28 seconds just before Anzac Day, was from the NGO, closely linked to the UN, known as *The International Commission of Jurists* (ICJ). On pages 22 to 23, the ICJ in their March 2023 document titled *The 8 March Principles for a Human Rights-Based Approach to Criminal Law Proscribing Conduct Associated with Sex, Reproduction, Drug Use, HIV, Homelessness and Poverty*<sup>241</sup> stated as follows under “PRINCIPLE 16 – CONSENSUAL SEXUAL CONDUCT”:

**“With respect to the enforcement of criminal law, any prescribed minimum age of consent to sex must be applied in a non-discriminatory manner. Enforcement may not be linked to the sex/gender of participants or age of consent to marriage.**

**Moreover, sexual conduct involving persons below the domestically prescribed minimum age of consent to sex may be consensual in fact, if not in law. In this context, the enforcement of criminal law should reflect the rights and capacity of persons under 18 years of age to make decisions about engaging in consensual sexual conduct and their right to be heard in matters concerning them.”**

So essentially what the ICJ are saying; **“that if a nine-year-old boy consents” to sex with a sixty-year-old man, then that sexual act is legal!”**

The commentary of lawyer Liz Yore – founder of the U.S. advocacy group “Yore Children”, from 3 minutes 48 seconds in, is most poignant – when she elucidates how people in the past awake to the Globalist agenda of the UN, its closely linked NGOs, the WHO, WEF etc, ridiculed by corrupt global mainstream media as tin pot conspiracy theorists, for claiming that the Globalist agenda embodied the normalisation of paedophilia, are now, in light of the apparent brazen arrogance of Globalist entities, clearly vindicated.

And rest assured, the March 2023 ICJ document, is merely the tip of the iceberg. The Stop World Control page<sup>242</sup> alludes to the UN’s best known sub-entity, the Wuhan Health Organisation documenting in its 2010 paper of its Regional Office for Europe and BZgA (Bundeszentrale für gesundheitliche Aufklärung – Federal Centre for Health Education in Cologne Germany) titled *Standards for Sexuality Education in Europe A framework for policy makers, educational and health authorities and specialists*<sup>243</sup> advocates for age groups 0 to 4, 4 to 6, 6 to 9, 9 to 12 and 12 to 15, **be given information in regard to masturbation. Yes, masturbation!**

The Stop World Control page<sup>244</sup> also describes the Dutch Rutgers Foundation – a worldwide publisher of sex education, which operates in 27 nations, and is a close partner of the WHO and UN,<sup>245</sup> and is funded by Bill Gates<sup>246</sup> and a full member associate<sup>247</sup> of the International Planned Parenthood Federation (IPPF).<sup>248</sup> Curiously, back in mid-June, I discovered that the Bill and Melinda Gates Foundation web page documenting their \$3,381,284 donation in November 2017<sup>249</sup> to Rutgers was removed sometime between March 26<sup>th</sup> and May 14<sup>th</sup> 2023.<sup>250</sup> And no less curious, is the fact that Stop World Control<sup>251</sup> uploaded its web page documenting UN normalisation of paedophilia, on May 6<sup>th</sup>, 2023.<sup>252</sup>

Rutgers being Dutch, means that The Netherlands is at the heart of this worldwide agenda to sexualize little children. Moreover, Rutgers's staff member Ineke van der Vlugt, was indeed among eighteen representatives of the international working group including as well as Doortje Braeken and Ada Dortch of the International Planned Parenthood Federation (IPPF), who contributed to the compiling of the just aforementioned *Standards for Sexuality Education in Europe A framework for policy makers, educational and health authorities and specialists*.<sup>253</sup> As Stop World Control<sup>254</sup> alluded to, what happens in The Netherlands, will spread worldwide: in the USA, Canada, Australia, the UK, Africa, Asia and everywhere else.

I have only described the veritable tip of the iceberg of this demonic agenda now seemingly, in unbridled complacent arrogance, removing its mask. I have watched a disturbing three minute video in Dutch, but with English subtitles,<sup>255</sup> of what I can only describe as female paedophiles, under the pretext of "professional duty," **describing masturbation to what we would call pre-school children!** To which raises the following questions:

1) In allusion to the Catastrophic Climate Change Scam, which I am in the process of researching in depth,<sup>256</sup>

"Do you truly believe that Globalists/UN/WHO/NGOs/WEF etc dedicated to the normalisation of paedophilia, are committed to 'saving the planet?'"

2) And in allusion to the COVID jab scam<sup>257</sup> and the WHO PLandemic/IHR,<sup>258</sup>

"Do you truly believe that Globalists/UN/WHO/NGOs/WEF etc dedicated to the normalisation of paedophilia, are committed to safely and effectively 'vaccinating' the entire population of the planet? Moreover, are you willing to allow the mass-murdering Ethiopian communist, Tedros, to become **Global Medical Dictator General?**"

3) If you are beholden to such malevolent paedophile normalising Globalist entities, why should we trust you with imposing your own Orwellian Ministry of Truth like bill upon us? In short, to paraphrase Thomas Jefferson, **"Your Orwellian bill is the natural ally of malevolent power and malevolent power only."**

In relation to the third point ... well no ... really all three ... in terms of the credibility and the nefarious agendas of these various Globalist entities, back in January 2023, **prostitutes flocked to Davos Switzerland to meet demand during the World Economic Forum's annual meeting**. Life Site News reported:

"Prostitutes are flocking to Davos, Switzerland and its surrounding areas, driven by the sex demand that accompanies the World Economic Forum's (WEF) annual meeting of many of the world's most powerful men.

Reports have confirmed that this year, as in previous years, prostitutes are increasingly being booked in and around Davos as WEF's 2023 meeting kicks off."<sup>259</sup>

You may ask; "What has the WEF got to do with the UN?" To which I quote the WEF article titled *"World Economic Forum and UN Sign Strategic Partnership Framework"* dated June 13<sup>th</sup>, 2019:

"New York, USA, 13 June 2019 – The World Economic Forum and the United Nations signed today a Strategic Partnership Framework outlining areas of cooperation to deepen institutional engagement and jointly accelerate the implementation of the 2030 Agenda for

Sustainable Development. The framework was drafted based on a mapping of existing collaboration between the two institutions and will enable a more strategic and coordinated approach towards delivering impact.”<sup>260</sup>

Moreover, the amazing movie “*Sound of Freedom*”, with a modest budget of just \$15 million compared to the latest and pretentiously budgeted Indiana Jones movie of \$286 million, exposes the global sex trafficking of children, is actively being maligned to the American public. As ludicrous as it sounds, as reported by *The Epoch Times*’ Roman Balmakov in his 17 minute piece titled “*Why Hollywood (and Media) Elites Don’t Want ‘Sound of Freedom’ to Succeed | Facts Matter*”<sup>261</sup> despite the fact that this movie is based on the true story of former Homeland Security agent Tim Ballard, and despite the fact that it exposes the self-evident reality that millions of children find themselves in, there are elite forces in both Hollywood and your corrupt global media, which have actively been working to suppress this movie.<sup>262</sup>

In particular, the incessant and baseless accusations linking *Sound of Freedom* to QAnon, but ignoring for example, that Noah Berlatsky, who wrote a Bloomberg hit piece on *Sound of Freedom*,<sup>263</sup> tweeted on February 21<sup>st</sup>, 2017 the following:

“Pedophiles are essentially a stigmatized group. Certain people get designated as deviants, people hate them.”<sup>264</sup>

Moreover, the ProStasia Foundation, of which Noah Berlatsky was its Director of Communications up until at least 2021,<sup>265</sup> is ostensibly devoted to fighting paedophilia but is a financial proxy and child protection partner to the MAP Support Club. MAP being the acronym for “Minor Attracted Persons!!”<sup>266</sup> No wonder, when one tries to look-up Noah Berlatsky’s Twitter account, they are presented with the following messages:

“These Tweets are protected. Only approved followers can see @nberlat’s Tweets. To request access, click Follow. Learn more.”<sup>267</sup>

... and when one looks-up Noah Berlatsky’s February 21<sup>st</sup>, 2017 tweet itself:

“You’re unable to view this Tweet because this account owner limits who can view their Tweets. Learn more.”<sup>268</sup>

Hmmmmmm??????? “... because this account owner limits who can view their Tweets.”

In this submission, I have incontrovertibly linked the Catastrophic Climate Change Scam and the COVID-19 jab scam as shoved down our throats by the various Globalist entities and our corrupt and obsequiously compliant global mainstream media. I started with two Geneva-based figures; namely Klaus Schwab; Executive Chair of the World Economic Forum – WEF, and the mass-murdering Ethiopian communist<sup>269</sup> Tedros Adhanom Ghebreyesus; Director-General of the United Nations agency – the Wuhan Health Organisation – WHO and their inextricable links to the mass-murdering and genocidal Chinese Communist Party. Clearly, their totalitarian agendas have presently the common goal of obliterating our fundamental liberties, rights and freedoms we have treasured but come to take too much for granted in the West as the decades have rolled by since my father arrived on these shores with his two sisters and mother who left a devastated European continent, made as such on the whim of a mass-murdering fascist lunatic, in 1950.

However, there are three more crucial Globalist players that I will briefly touch upon. Firstly, the close advisor to Klaus Schwab – Yuval Noah Harari. Secondly, one of the three mentors of Klaus Schwab – Henry Kissinger,<sup>270</sup> who served as the 56<sup>th</sup> American Secretary of State from September

22, 1973 to January 20, 1977 under the Richard Nixon and Gerald Ford administrations.<sup>271</sup> And finally, Peter Daszak, the aforementioned President of the U.S. NGO; the Eco-Health Alliance.

Yuval Noah Harari was born in Israel in 1976. He received his PhD from the University of Oxford in 2002 and is currently a lecturer at the Department of History at the Hebrew University of Jerusalem.<sup>272</sup> However, he is also a senior advisor to Klaus Schwab<sup>273</sup> and claims in the **true spirit of trans-humanism**, that humans are “**hackable animals**”<sup>274</sup> and that fundamental Christian values and doctrine of freedom, free will and the soul will become a thing of the past!<sup>275</sup> [Hmmm ... Harari’s trans-humanist agenda seems to fit like a glove with your *Communications Legislation Amendment (Combating **Mis-Dis-Mal** information) Bill 2023!*] Moreover, Harari claims that:

“History began when humans invented gods, and will end when humans become gods.”<sup>276</sup>

And if you think the WEF and their characters like Schwab and Harari are just wackos not to be taken seriously, then I shall remind you:

“New York, USA, 13 June 2019 – The World Economic Forum and the United Nations signed today a Strategic Partnership Framework outlining areas of cooperation to deepen institutional engagement and jointly accelerate the implementation of the 2030 Agenda for Sustainable Development. The framework was drafted based on a mapping of existing collaboration between the two institutions and will enable a more strategic and coordinated approach towards delivering impact.”<sup>277</sup>

Moreover, in Davos Switzerland in a January 2016 interview in French, Schwab stated humans will have a chip implanted in their brain or skin within 10 years.<sup>278</sup>

At Evian, France, May 21, 1992, Henry Kissinger was in attendance at the Globalist Bilderberger meeting.<sup>279</sup> It has been stated that the following quote by Henry Kissinger, in the midst of the then Los Angeles riots, sparked by the police bashing of the black American Rodney King the year before, and the subsequent trial acquitting those police officers in late April 1992,<sup>280</sup> was transcribed from a tape recording made by one of the Swiss delegates. Admittedly, no such recording has ever been provided,<sup>281</sup> but the alleged quote is still chillingly reminiscent of the COVID-19 lockdowns, the Catastrophic Climate Change Scam and a window into the future implications and the overall agenda of your Orwellian Ministry of Truth mis-dis-mal information bill. Moreover, I read this quote documented in an ebook published on November 21<sup>st</sup> 2018.<sup>282</sup> Hence, whoever made this quote or wrote it, did so well before the outbreak of the COVID PLandemic.

“Today American's would be outraged if U.N. troops entered Los Angeles to restore order; tomorrow they will be grateful. This is especially true if they were told there was an outside threat from beyond, whether real or promulgated, that threatened our very existence. It is then that all peoples of the world will plead with world leaders to deliver them from this evil. **The one thing every man fears is the unknown. When presented with this scenario, individual rights will be willingly relinquished for the guarantee of their well being granted to them by their world government.**”<sup>283</sup>

And in the following, there absolutely no doubt, when Henry Kissinger in 1974, while he was American Secretary of State, wrote his infamous “*Implications of Worldwide Population Growth For U.S. Security and Overseas Interests*” – THE KISSINGER REPORT.<sup>284</sup> The following paragraph embodies its overall agenda of population reduction:

“There is an alternative view which holds that a growing number of experts believe that the population situation is already more serious and less amenable to solution through voluntary

measures than is generally accepted. It holds that, to prevent even more widespread food shortage and other demographic catastrophes than are generally anticipated, even stronger measures are required and some fundamental, very difficult moral issues need to be addressed. **These include, for example, our own consumption patterns, mandatory programs, tight control of our food resources.** In view of the seriousness of these issues, explicit consideration of them should begin in the Executive Branch, the Congress and the U.N. soon.”<sup>285</sup>

In 2023, the Dutch farmers under the WEF-puppet tyrant Mark Rutte,<sup>286</sup> no doubt would attest to Rutte’s implementation of **“mandatory programs, tight control of our food resources.”**

Finally, Peter Daszak, President of the U.S. NGO; the Eco-Health Alliance who was involved with Anthony Fauci in funding dangerous viral Gain of Function research at the Wuhan lab,<sup>287</sup> before the outbreak of COVID. Going a few years further back to March 27<sup>th</sup>, 2015 – **yes, I repeat; March 27<sup>th</sup>, 2015:**

“Daszak reiterated that, until an infectious disease crisis is very real, present, and at an emergency threshold, it is often largely ignored. To sustain the funding base beyond the crisis, he said, we need to increase public understanding of the need for MCMs (Medical Counter Measures) such as a pan-influenza or pan-coronavirus vaccine. **A key driver is the media, and the economics follow the hype.** We need to use that hype to our advantage to get to the real issues. **Investors will respond if they see profit at the end of process,** Daszak stated.”<sup>288</sup>

Hmmmm .... **“A key driver is the media, and the economics follow the hype”** and **“Investors will respond if they see profit at the end of process”**. Sounds like the very epitome of crony capitalism, or as trans-humanist cyborg Klaus would sanitise it; stakeholder capitalism – which of course, has driven the jab scam from December 2020.

After just alluding to the agenda of the three Globalist sociopaths; Yuval Noah Harari, Henry Kissinger and Peter Daszak, and their ilk in general for this submission, I will conclude with a chillingly eerie, prescient but awe inspiring speech by the Jewish Holocaust survivor; Vera Sharav in Nuremberg on the 75<sup>th</sup> anniversary of the Nuremberg Code on the 20<sup>th</sup> of August 2022.<sup>289</sup> Please note my commentary in ***italicised bold*** within “[ ]”.

“I came to Nuremberg to provide historical context to the current global threat confronting our civilisation. These past two and a half years have been especially stressful – as painful memories were rekindled.

In 1941, I was three-and-half-years-old when my family was forced from our home in Romania and deported to Ukraine. We were herded into a concentration camp – essentially left to starve. Death was ever-present. My father died of typhus when I was five.

In 1944, as the Final Solution was being aggressively implemented, Romania retreated from its alliance with Nazi Germany. The government permitted several hundred Jewish orphans under the age of 12 to return to Romania. I was not an orphan; my mother lied to save my life.

I boarded a cattle car train – the same train that continued to transport Jews to the death camps – even as Germany was losing the war. Four years elapsed before I was reunited with my mother.

## **The Holocaust serves as the archetypal symbol of unmitigated evil**

- Moral norms and human values were systematically obliterated. [*Today the normalisation of paedophilia and the promotion of dangerous genital mutilation surgery of children.*<sup>290</sup> *Moreover, the acceptance of abortion and even infanticide of babies surviving abortion.*<sup>291</sup>]
- The Nazi system destroyed the social conscience.
- Millions of people were worked to death as Slave labourers.
- Others were abused as experimental human guinea pigs.

The Holocaust **did not begin in the gas chambers of Auschwitz and Treblinka**. The Holocaust **was preceded by 9 years of incremental restrictions on personal freedom**, and the suspension of legal rights and civil rights. [*Yes of course ... we are not yet as bad as Hitler's National Socialist Germany. However your Communications Legislation Amendment (Combating Mis-Dis-Mal information) Bill 2023 is a huge step in that direction.*]

The stage was set by fear-mongering and hate-mongering propaganda. A series of humiliating discriminatory government edicts demonized Jews as “spreaders of disease.” We were compared to lice.”<sup>292</sup> [*Today, the demonisation of unjabbed people such as myself as “Nazis” by the corrupt mainstream media.*<sup>293</sup>]

**The real viral disease that infected Nazi Germany is Eugenics— Eugenics is the elitist ideology at the root of all genocides.**

- Eugenics is cloaked in a mantle of pseudo- science.
- It was embraced by the academic and medical establishment as well as the judiciary — in Germany and the United States.
- Eugenicists justify social and economic inequality.

They legitimise discrimination, apartheid, sterilisation, euthanasia, and genocide. The Nazis called it “ethnic cleansing” — for the protection of the gene pool.

**Medicine was perverted from its healing mission and was weaponized.** [*For example, your Nuremberg Code violating jab mandates.*]

First, it was to control reproduction through forced sterilisation; then it was to eliminate those deemed to be “sub-human” —*Untermenschen*. The first victims of medical murder were 1,000.

German disabled infants and toddlers. This murderous operation was expanded to an estimated 10,000 children up to age 17. The next victims were the mentally ill; they were followed by the elderly in nursing homes. All of these human beings were condemned as “worthless eaters”.

Under Operation T-4, [*As discussed in my book*<sup>294</sup>] designated hospitals became killing stations where various extermination methods were tested – including Zyklon B — the gas that was used in the death camps.

**The objective of the Nazi Final Solution** was to annihilate the entire 11 million Jewish Population of Europe as quickly and efficiently as possible. The Nazis enacted discriminatory laws; they utilised modern technology; low-cost industrial methods; an

efficient transportation system; and a highly trained bureaucracy that coordinated the industrial genocidal process. The objective was high speed, maximum efficiency at lowest cost.

The human casualties of this unprecedented genocide were 6 million Jews and 9 million other people whom the Nazis dehumanised as *Untermenschen*. (sub-humans)

“The purpose of Holocaust memorials is to warn and inform future generations about how an enlightened, civilised society can be transformed into a genocidal universe ruled by absolute moral depravity. [*Today the normalisation of paedophilia and the promotion of dangerous genital mutilation surgery of children.*<sup>295</sup> *Moreover, the acceptance of abortion and even infanticide of babies surviving abortion.*]<sup>296</sup>

If we are to avert another Holocaust, we must identify ominous current parallels before they poison [*Indeed as they are right now*] the fabric of society.

Since the Nazi era, the study of history and most of the humanities – including philosophy, religion, and ethics – has been overshadowed by an emphasis on utilitarian science and technology.

As a result, few people recognise the foreboding similarities between current policies and those under the Nazi regime.

By [*Hitler’s National Socialists*] declaring a state of emergency, in 1933 [*and likewise the American Deep State in 2020*],<sup>297</sup> constitutionally protected personal freedom, legal rights, and civil rights were swept aside. Repressive, discriminatory decrees followed.

In 1933, the primary target for discrimination were Jews; today, the target is people [*such as myself*] who refuse to be injected with experimental, [*Nuremberg Code Violating*]<sup>298</sup> genetically engineered vaccines.<sup>299</sup> Then and now, government dictates were crafted to eliminate segments of the population.

In 2020, [U.S.] government dictates forbade hospitals from treating the elderly in nursing homes.<sup>300</sup> **The result was mass murder.** Government decrees continue to forbid doctors to prescribe life-saving, [U.S.] FDA approved medicines; government-dictated protocols continue to kill.

The media is silent – as it was then. The media broadcasts a single, government-dictated narrative – just as it had under the Nazis. Strict censorship silences opposing views. In Nazi Germany few individuals objected; those who did were imprisoned in concentration camps. Today, doctors and scientists who challenge the approved narrative are maligned; their reputations trashed. They risk losing their license to practice<sup>301</sup> as well as having their homes and workplace raided by SWAT teams.<sup>302</sup>

### **The moral significance of the Nuremberg Code cannot be overstated:**

The Nuremberg Code is the most authoritative, internationally recognised document in the history of medical ethics.<sup>303</sup>

This landmark document was formulated in response to the evidence of medical atrocities committed by Nazi physicians and scientists.

The Code sets forth moral boundaries for research involving human beings.

The Nuremberg Code rejects the ideology of Eugenics and **unequivocally** asserts the primacy and dignity of the individual human being – as opposed to “*the greater good of society.*” [*Which your ilk obsess over to obliterate our fundamental freedoms and liberties.*]

American jurists who formulated the Nuremberg Code incorporated the official 1931 German “*Guidelines for Human Experimentation*” authored by Dr. Julius Moses. Those Guidelines remained legally in force until 1945. The Nazis violated them in their entirety. Dr. Moses, who was Jewish, was deported to Theresienstadt where he died.

**The Nuremberg Code defined foundational, universal moral and legal standards;** affirming fundamental human rights. These human rights apply to every human being. [*This is what your ilk have to understand and acknowledge!*]

- The Code sets limits on the parameters of permissible medical experiments.
- Equally important, the Nuremberg Code holds doctors and research investigators **personally responsible** to ensure the human subjects’ safety and to ensure that the person freely gave his voluntary, fully informed consent. The standards of the Nuremberg Code are incorporated in the International Criminal Code. They are legally applicable today in peacetime and during war.

The objective of the Nuremberg Code is to ensure that medicine, never again deviates from the precautionary ethical principle, “*First, do no harm.*” The Nuremberg Code has served as a blueprint for subsequent national and international codes of human rights – to ensure that:

- the rights and dignity of human beings are upheld;
- and to ensure that medical doctors never again engage in morally abhorrent experiments.
- Like the 10 Commandments, not a word of the Code may ever be changed.

The first of 10 ethical principles lays down the foremost ethical requirement – which is spelled out in great detail:

“*The voluntary consent of the human subject is absolutely essential*”. [**Please take note!**]

“*This means that the person involved should have legal capacity to give consent; should be so situated as to be able to exercise free power of choice, without the intervention of any element of force... constraint or coercion; and should have sufficient knowledge and comprehension of the elements of the subject matter involved as to enable him to make an understanding and enlightened decision. This... requires that before the acceptance... of an affirmative decision by the experimental subject... [he] should be [informed of] the nature, duration, and purpose of the experiment; the method and means by which it is to be conducted; all inconveniences and hazards reasonably to be expected; and the effects upon his health or person which may possibly come from his participation in the experiment.*”

*The duty and responsibility for ascertaining the quality of the consent rests upon each individual who initiates, directs or engages in the experiment. It is a personal duty and responsibility which may not be delegated to another with impunity.*” [**Of course, your Communications Legislation Amendment (Combating Mis-Dis-Mal information) Bill 2023 empowers you with “impunity.”**]

**The genocidal culture** that permeated the Nazi regime **did not end in 1945**. It metastasised in the United States.

At the end of the war, US government agents helped 1,600 high ranking Nazi scientists, doctors, and engineers to evade justice at Nuremberg.

These Nazi technocrats facilitated the murderous Nazi operations. They were Hitler's partners in crimes against humanity. They were secretly smuggled into the US under Operation Paperclip. This was in violation of explicit orders by President Harry Truman. These Nazi criminals were placed in high-level positions at major American scientific and medical institutions where they continued their work.

What's more, these Nazi technocrats trained a generation of American scientists, doctors, and engineers. This is how Nazi methods, and the immoral disregard for human values were entrenched in America.

In 1961, in his farewell address to the nation, **President Dwight Eisenhower** warned against the increasing dominance of "*the military-industrial complex*" whose "*total influence – economic, political, even spiritual – is felt [everywhere]*"

Eisenhower warned: "*we must be alert to the danger that public policy could itself become the captive of a scientific-technological elite.*"

In 1979, a report to the President, by the US Commission on the Holocaust, chaired by Auschwitz survivor Elie Wiesel warned:

*"...the inclination to duplicate the Nazi option and once again to exterminate millions of people remains a hideous threat."*

Those who declare that Holocaust analogies are "off limits"—are betraying the victims of the Holocaust by denying the relevance of the Holocaust.

The Nuremberg Code has served as the foundation for ethical clinical research since its publication 75 years ago.

The Covid pandemic is being exploited as an opportunity to overturn the moral and legal parameters laid down by the Nuremberg Code.

The Nuremberg Code is our defence against abusive experimentation. [*As embodied in your COVID jabs.*]

**Humanity is currently under siege by the global heirs of the Nazis. [*As discussed earlier – Klaus Schwab himself is one of them!*]<sup>304</sup>**

A posse of ruthless, interconnected, global billionaires have gained control over national and international policy-setting institutions. They have embarked on implementing a diabolical agenda:

- Overthrow democracy and Western civilisation;
- Depopulate the global population;
- Eliminate nation-states and establish One World Government;
- Eliminate cash and establish one digital currency;
